4. Purpose of SRE Policy

- This policy has been written as a statutory requirement and to give clear guidance to staff and outside visitors about the content, organisation and approach to teaching SRE
- Give information to parents and carers about what is taught and when
- Give parents and carers information about their involvement with SRE
- Give a clear statement on what the school aims to achieve from SRE and why it thinks SRE is important
- Clarify the content and manner in which SRE is delivered

5. How the Policy was Developed

This policy was developed as part of our statutory responsibility by school governors, with advice from The London Borough of Southwark, and delegated to key members of teaching staff.

6. Definition of SRE

SRE is lifelong learning about sex, sexuality, emotions, relationships and sexual health. It involves acquiring information, developing skills and forming positive beliefs, values and attitudes. SRE has a key part to play in the personal, social, moral and spiritual development of young people. It begins informally in the home with parents and carers, long before any formal education takes place at school. Young people's entitlement to SRE is enshrined in the terms of the Education Act (1996).

The DfES Guidance 2000 offered this definition: *"SRE is the lifelong learning about physical, moral and emotional development. It is about the understanding of the importance of marriage for family life, stable and loving relationships, respect, love and care. It is also about the teaching of sex, sexuality, and sexual health. It is not about the promotion of sexual orientation or sexual activity."*

The National Sex Education Forum highlighted that SRE also involves:

- Acquiring information
- Developing skills
- Forming positive beliefs and attitudes

7. Aims of SRE

- Develop confidence to talk, listen and think about feelings and relationships
- Address concerns and correct misunderstandings and be able to protect themselves and ask for help
- Develop skills to make and maintain positive relationships
- Develop positive attitudes and values and respect differences in opinions
- Develop a positive self-image and high self esteem
- Gain accurate knowledge and understanding about sexuality and relationships
- Develop personal responsibility for one's actions
- Know where to get confidential advice and support

8. Moral and Values Framework

SRE will be delivered within the school's agreed aims, values and moral framework which is sensitive to the needs and beliefs of pupils, parents / carers and other members of the school community. This will be delivered within the school's agreed equality plan.

Sex and Relationships Education (SRE) supports and guides pupils in life-long learning about relationships, emotions, the human biology of sex and sexuality. Along with parents and carers, we help our pupils to understand and manage their physical and emotional development in adolescence, and prepare for the decisions to be made in adult life.

We believe that pupils should have accurate information that relates to their needs. They need help to explore their own feelings and attitudes, and those of society, in order to develop values on which to base decisions about relationships. They need to learn the

communication skills necessary to help them take increasing responsibility for their own sexual behaviour.

Thinking about morals and values also includes:

- Respect for self and others
- Non-exploitation in relationships
- Commitment, trust and love within relationships
- Honesty with self and others
- Self-awareness
- Exploration of rights, duties and responsibilities
- Understanding diversity regarding religion, culture and sexual orientation

9. Content and Organisation of the Programme

- 9.1 Timetable allocation: One discreet specific SRE unit of work per year group per year. Termly, as required, to link in with statutory Science curriculum.
- 9.2 Groupings: Whole class teaching, except where information is particularly sensitive. Groupings may be male/female only, as appropriate.
- 9.3 Staff Involved: The lessons will be delivered by the class teacher.
- 9.4 Where taught: Dedicated PSHE lessons; SRE lessons and Science lessons. We will follow the programme of SRE Education recommended by The London Borough of Southwark.
- 9.5 How taught:
 - Teachers will set a group agreement with pupils to ensure that an atmosphere is created, where pupils feel able to discuss concerns, feeling and relationships
 - It should be recognised that questions from pupils will be addressed and dealt with in the most appropriate manner and not disregarded. The form in which these questions are addressed may be in group activities, or on a one-to-one basis, as appropriate.
 - Resources will be assessed to ensure that they are appropriate to the age and maturity of pupils. They will take into account equality of opportunity through their use of language, cultural attitudes and images, avoiding stereotyping, racism and sexism.
 - A variety of teaching and learning styles will be used, including videos, information sheets, pamphlets, textbooks, visual aids and models, games, role-play, discussion, group work, interactive CD ROMS, the Internet and visits by theatre groups.

10. Confidentiality Statement

The school will ensure that pupils know that teachers cannot offer unconditional confidentiality and are reassured that their best interests will be maintained. They will be reminded that if confidentiality has to be broken, they will be informed first and then supported as appropriate. They are encouraged to talk to their parents or carers and are provided with support to do so.

The school will ensure that all staff understand that they cannot offer unconditional confidentiality to pupils. They will work within the school's agreed procedure for recording and reporting disclosures and the nature of access to this information.

11. Assessing SRE and Monitoring the Programme

The SRE Lead will be responsible for:

- Ensuring the policy and programmes are implemented as agreed
- Supporting staff to assess pupils progress
- Recommending targets for whole school development
- Evaluation of the programme will be made by assessing, the attitudes of the pupils, the development of their personal skills and the knowledge and understanding they have gained. Review forms part of the content and is an ongoing process. The views of pupils, staff and parents will be sought and taken into account as the programme develops and changes.

12. Teachers' Responsibilities

To reassure parents/carers, pupils and governors that the personal beliefs and attitudes of teachers will not influence the teaching of SRE; all those contributing to the programme are expected to work within the aims listed above.

13. Training Staff to Deliver SRE

It is important that staff delivering SRE work within the values framework of this policy feel confident, skilled and knowledgeable to deliver effective SRE. Continuing professional development will be provided through a range of options: individual study and development/ in-house CPD/ external training courses. Training could include:

- What to teach and when
- Leading discussions about attitudes and values
- Information updates
- Practising a variety of teaching methods
- Facilitating group discussions
- Involving pupils in their own learning
- Managing sensitive issues

14. Working with Parents/Carers and Child Withdrawal Procedures

On entry to the school, parents are invited to read the SRE policy, which is available on the school website. This helps to establish consultation and a partnership with parents, which reinforces the dual responsibility for SRE learning. Parents are kept informed about the content of the programme.

We place the utmost importance on sharing equal and joint responsibility with parents/carers for their children's education, including sexual matters. We will do our best to find out from them any religious or cultural views they may have which may affect the PSHE they wish to be given to their children, although we would consider carefully any request that compromised our equal opportunities policy.

We will take every opportunity to inform and involve parents/carers:

- By inviting parents/carers to discuss personal development when their child enters the school
- By inviting parents/carers to a meeting each year to discuss SRE for their year group in the school. This includes the sharing of resources and teaching materials to be used.

Section 405 of the Education Act 1996, gives parents the right to withdraw their children from any, or all parts of a school's programme of sex education - although not those elements included in the National Curriculum Orders for Science, or any other part of the National Curriculum.

If a parent wishes to withdraw their child from SRE lessons, we ask that they put this request in writing to the Head of School in the first instance, prior to the SRE programme being delivered, following attendance at the year group SRE meeting in order to be fully informed of their decision. At this meeting, it will be clarified what the child will do when they are withdrawn from the SRE specific sessions. The Head of School will follow the written request up with a meeting with parents and carers.

We should like to make clear that even when a pupil has been withdrawn from SRE lessons, if the pupil should ask questions at other times, these questions would be answered honestly by staff.

15. Disseminating and Monitoring the SRE Policy

A copy of this policy will be supplied to all staff and governors and included within the staff handbook. A full copy will be made freely available to parents on request and if appropriate a summary will be published in the school prospectus. Copies will also be supplied to other professionals whose work relates to SRE or who may be involved in its delivery.
